

## 【 Notice of Business Acquisition in Thailand: SPK MOTORPARTS CO., LTD. 】

SPK MOTORPARTS CO., LTD. (headquartered in Bangkok, Thailand; Masayuki Hida, Managing Director; hereinafter “SMC”) which is an overseas subsidiary of SPK Corporation (headquartered in Osaka, Japan; Kyoichiro Oki, President; hereinafter “SPK”), took over the business of selling of automotive and industrial parts from DHANA SIRM CO., LTD.
